




BOREHOLE DRILLING

COMMERCIAL WATER SUPPLY

THE GROWING COST OF WATER UTILITIES IS HAVING AN INCREASINGLY HARD IMPACT ON MANY COMPANIES. THE SUPPLY OF WATER ALONE CAN ACCOUNT FOR ANNUAL WATER BILLS IN EXCESS OF TENS OR EVEN HUNDREDS OF THOUSANDS OF POUNDS. IN MANY AREAS OF THE UK THERE ARE HUGE RESERVOIRS OF WATER (OR AQUIFERS) LESS THAN ONE HUNDRED METERS BELOW THE GROUND THAT COULD EASILY BE TAPPED INTO. THIS COULD OFFER SIGNIFICANT OPERATIONAL SAVINGS WHICH DRILCORP LTD HAS REPEATEDLY ACHIEVED. BY DRILLING INTO THESE AQUIFERS, DRILCORP HAS PROVIDED INDEPENDENT WATER SUPPLY TO SEVERAL COMPANIES, NOT FOREGOING QUALITY NOR QUANTITY. LICENSING AND NOTIFICATION

UNDER CURRENT ENVIRONMENT AGENCY REGULATIONS, ANY BOREHOLE OR WELL ABSTRACTING LESS THAN 20M³ WATER PER DAY (4400 GALLONS PER DAY) DOES NOT NEED LICENSING. HOWEVER, FOR INTENDED ABSTRACTIONS IN EXCESS OF 20M³ PER DAY LICENSING IS REQUIRED AND, BEFORE ANY WORKS CAN COMMENCE, A SECTION 32 CONSENT IS LEGALLY REQUIRED FROM THE LOCAL ENVIRONMENT AGENCY TO DRILL AND TEST PUMP ANY BOREHOLE. FOLLOWING THE SUCCESSFUL COMPLETION OF THE WORKS, AN ABSTRACTION LICENSE IS ALSO REQUIRED.

IN ADDITION TO THIS, DETAILS OF BOREHOLES DRILLED DEEPER THAN 15 METRES MUST LEGALLY BE FORWARDED TO THE BRITISH GEOLOGICAL SURVEY. THE RECORDS SHOULD ALSO BE RETAINED WITH ANY PROPERTY DEEDS. AS PART OF OUR COMMITMENT TO PROVIDE A COMPLETE SERVICE TO OUR CLIENTS, DRILCORP HAS THE EXPERTISE AND DECADES OF EXPERIENCE TO HANDLE ALL SUCH LEGAL REQUIREMENTS QUICKLY AND EFFICIENTLY.
